- **4. PUBLIC FORUM** Mark Powers (121 Foursome Ln.) recommended extending the CID now in case legislature makes changes regarding CID statutes. He stated that CID could be extended for 27 years. He also recommended holding an election in April 2025 that included a ballot measure to reduce the CID tax once the current bond is repaid and to extend the tax until the dissolution of the CID. Including both measures would eliminate the need for two separate elections.

- **B. Pro Shop/Golf Course** Nate Benedict
